Notice is hereby given to the Securities and Exchange Commission and the Philippine Dealing & Exchange Corp. that Manila Electric Company (the "Company" or "Meralco") received on October 22, 2025 a Notice of Violation ("Notice") from the Philippine Stock Exchange (the "Exchange"). The Exchange found that the Company violated Sections 4.4(d) and 4.4(u) of Article VII of the Consolidated Listing and Disclosure Rules, and assessed a penalty in the amount of One Hundred One Thousand Pesos (PhP101,000.00).

After a review of the Notice issued by the Exchange, the Company decided to pay the assessment today, October 28, 2025.
