

INVITATION TO PARTICIPATE AS CSP OBSERVER

In accordance with Section 9, Article IV of the Energy Regulatory Commission's Resolution No. 16, Series of 2023 entitled "***Implementing Guidelines for the Procurement, Execution, and Evaluation of Power Supply Agreements entered into by Distribution Utilities for the Supply of Electricity to their Captive Market***" (the "CSP Guidelines"), the Bids and Awards Committee – Power Supply Agreements (BAC-PSA) of Manila Electric Company (MERALCO) is opening the procurement proceedings for its **Contract Capacity of 200 MW (AC, net), Effective February 2026 ("CSP")** to the following entities or groups:

- (a) Consumer representatives from the Department of Trade and Industry (DTI)-accredited consumer groups or from the Securities and Exchange Commission (SEC)-registered consumer groups;
- (b) Community representatives, such as the local chamber of commerce, homeowners associations, local pastoral councils, academe, parent-teachers associations; and
- (c) Interested civil society organization and consumers.

The above identified entities or interested consumers shall inform MERALCO's BAC-PSA of its/his/her interest to participate as observer (the "**CSP Observer**") by submitting:

- (i) a completed copy of the **Letter of Interest to Participate as CSP Observer** attached hereto as **Annex "A"**; and
- (ii) an executed **Sworn Undertaking** attached hereto as **Annex "B"**,

For orderly conduct and administrative efficiency of the CSP Proceedings, only the first two groups/entities/consumers for each category identified in paragraphs (a) to (c) above which/who successfully complete the requirements by the stated deadline shall be given access to the scheduled meetings of the CSP as published in the Invitation to Bid/Terms of Reference.
