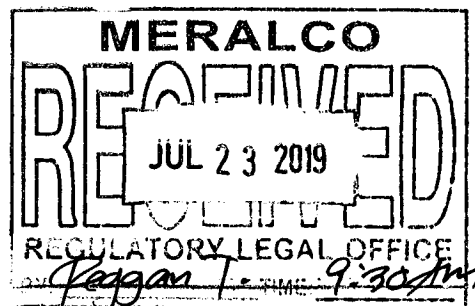

ORDER

On 01 July 2019, Manila Electric Company (MERALCO) and filed an *Application* dated 27 June 2019, seeking authority to implement their proposed emergency capital expenditure (CAPEX) program for the regulatory year (RY) 2020, with prayer for the issuance of provisional authority (*Application*).

On 09 July 2019, the Commission issued an *Order and Notice of Public Hearing* setting the instant case for determination of compliance with the jurisdictional requirements, expository presentation, Pre-trial Conference, and presentation of evidence on 20 August 2019 (Tuesday) at 2:00 PM at the ERC Hearing Room, 15th Floor, Pacific Center Building, San Miguel Avenue, Pasig City.

Set forth below is item one (1) of the first paragraph of the dispositive portion of the said *Order* which read as follows:

(This space is intentionally left blank.)

xxx

Accordingly, MERALCO is hereby directed to:

- 1) Cause the publication of the attached Notice of Public Hearing in two (2) newspaper of nationwide circulation in the Philippines at their own expense, twice (2x) within two (2) successive weeks, the dates of publication not being less than seven (7) days apart and the date of the last publication to be made not later than ten (10) days before the date of the scheduled initial hearing;

xxx

Section 4, Rule 22 of the ERC's Rules of Practice and Procedure provides the following publication requirements for applications or petitions with potential effects on consumers:

“Section 4. Publication and Other Requirements – The notice of hearing for any application or petition for rate adjustment or for any relief affecting the consumers shall be published by the applicant or petitioner, at their own expense, at least twice for two (2) successive weeks in two (2) newspapers of nationwide circulation, the last day of publication not to be later than ten (10) days before the scheduled hearing. xxx”

(Emphasis supplied)

The Commission noted, however, that due to inadvertence, a clerical error was made under item one (1) of the first paragraph of the dispositive portion of the *Order*. In line with this, Section 4, Rule 22 of Resolution No. 38, series of 2006, entitled “*A Resolution Promulgating the Energy Regulatory Commission's Rules of Practice and Procedure*,” provides that clerical mistakes in orders and decisions may be corrected by the Commission at any time, *to wit*:

“Section 4. Correction of Clerical Mistakes. – Clerical mistakes in orders or decisions arising from oversight or omission may be corrected by the Commission at any time on its own initiative, or on motion of any party.”

(Emphasis supplied)

In view thereof, the first item of the first paragraph of the dispositive portion should read as follows:

(This space is intentionally left blank.)

xxx

Accordingly, MERALCO is hereby directed to:

- 1) Cause the publication of the attached Notice of Public Hearing in two (2) newspapers of nationwide circulation in the Philippines at their own expense, twice (2x) within two (2) successive weeks, and the dates of publication to be made no less than seven (7) days apart and the date of last publication to be made no later than ten (10) days before the date of the scheduled initial hearing;

MERALCO is hereby **DIRECTED** to comply with the Commission's *Order* dated 09 July 2019, as modified and corrected by this Order.
