SUPPLEMENTAL NOTICE NO. 1

To all interested bidders:

For clarity, the definition of "Outstanding Dispute" as appearing on page 3 of the Bid Requirements is qualified as follows:

"Outstanding Dispute" refers to any pending judicial, administrative, contractual or alternative dispute resolution proceeding between the Bidder or any of its Affiliates engaged in power generation, on one hand, and Meralco, on the other, provided that the following pending judicial or administrative cases involving the Bidder or any of its Affiliates and Meralco are excluded from the definition of Outstanding Dispute:
